In practical applications RSA, DSA, ECDSA, and similar public key cryptosystems are commonly used. Their security depends on assumptions about the difficulty of certain problems in number theory, such as the Integer Prime Factorization Problem or the Discrete Logarithm Problem. However, in 1994 Peter Shor showed that quantum computers could break any public-key cryptosystembased on these hard number theory problems. This means that if a reasonably powerful quantum computer could be built, it would put essentially all modern communication into peril. In 2001, Isaac Chuang and

NeilGershenfeldimplemented Shor'salgorithmona7-qubitquantumcomputer. In 2007 a 16-qubit quantum computer was demonstrated by a start-up company with the prediction that a 512-qubit or even a 1024-qubit quantum computer would become available in 2008. Some physicists predicted that within the next 10 to 20 years quantum computers will be built that are sufficiently powerful to implement Shor's ideas and to break all existing public key schemes. Thus we need to look ahead to a future of quantum computers, and we need to prepare the cryptographic world for that future.

Armine Ishkanian

explores how far the growth of civil society depends on a country's historical, political and socio-cultural context; and how far foreign aid, often provided with conditions which encouraged the promotion of civil society, had an impact on democratization. Based on extensive original research, including fieldwork interviews with participants, *Democracy Building and Civil Society in Post-Soviet Armenia* considers various democratization initiatives in recent years, and assesses how far the Armenian experience is similar to, or different from, the experiences of other post-Soviet states.

Governing the Post-communist City Feb 15 2022 When faced with the rapid and disorienting transition from communism to democracy, many eastern European leaders sought simple, immediately rewarding answers to complex policy problems. During the "Orange Revolution" in Ukraine, the second largest country in Europe came close to a violent break-up similar to that in neighboring Moldova, which witnessed a violent secession of the Transdnistria region. The study examines voting behavior and political attitudes in two groups of regions: those which were under Russian, Ottoman, and Soviet rule; and those which were under Austro-Hungarian, Polish, Romanian, and Czechoslovak rule until World War I or World War II. This book attributes the regional political divisions to the differences in historical experience. This study helps us to better understand regional cleavages and conflicts, not only in Ukraine and Moldova, but also in other cleft countries.
